Quotation for the supply of School Bus (Tata City Ride SKL 30+A+D) LP 410/35 and not by name. The quotations will be opened in the office of the undersigned at 11 AM on 28.07.2025.

2. The quotations shall be submitted according to the terms and conditions specified in paragraphs 3 to 8. Unless specified otherwise in the quotations, it shall be constructed that the terms and conditions stipulated hereunder have been agreed to.
3. The rates should be F.O.R. and should include excise duty, sales tax, freight, any other taxes, rates or impositions which are leviable e.g., packing charges in respect of the supplies. The school/ institution shall not be liable to pay any tax, freight, etc. which has not been expressly stipulated in the quotation in the event of acceptance of the quotation.
4. There should not be any overwriting or corrections in the quotation. If a figure is to be amended, it should be neatly scored out, the revised figure written above and the same attested with full signature and date. In the absence of such attestation the quotation is liable to be rejected.
5. The undersigned does not bind himself/herself to accept the lowest quotation and reserves the right to accept the quotation in whole or in part i.e., with respect to all the articles mentioned in the attached statement or in respect of one or more than one articles specified in the attached statement as he/she may decide.
6. On acceptance of the quotation it will become a contract and the contractor shall be bound by the terms and conditions of the quotation.
